Best Practices**Career Guidance and Counseling****Goal**

The object of conducting Career Guidance and Counseling Centre in college for all students is to prepare them against various types of competitive examination, Interview techniques and soft skill development & enhance the overall personality in addition to the prescribed syllabus of classes. The student gets opportunity to prepare various subjects necessary for MPSC, UPSC & various competitive examinations.

The Context:

Career Guidance and Counseling Centre has been working since last four years in college for all students who are interested and want to make career through competitive examination. Group discussion, PPT, lectures on different subjects is organized through Career Guidance and Counseling Centre. Students use books, internet, referencing periodicals, newspapers in this centre regularly. They are taking these things seriously along with their regular subjects.

The practice

The practice & implementation of competitive examination is becoming effective & interesting. It is conducted after the regular schedule of college. Students visit the centre during off lecture time. Teachers take efforts for the students. Workshops, regular competitive examination are arranged for student participation & interaction. The students are encouraged to participate in different activities organized by other institutions.

Evidence of success

Two students are succeeded in MPSC Clerk level examination. The students from remote & tribal areas are getting benefited and our center inculcates good manners & tries to make them good citizens. The students are happy & satisfied with CGCC education. They are finding their future & career through this centre.

Problems encountered and resources required

The main problem encountered in implementing the practice is the socio-economic backwardness of most students, who belong to sugarcane cutting worker's family. Essential measures are adopted to fulfil the requirements of the students in this centre. It requires both human and financial support for the centre to run appropriately.

Note

The career guidance and counselling cell had achieved to maintain database of suitable competitive exams related jobs for student.

2.Health Awareness and Women Empowerment Programme.

Goal:

To create an awareness among students and women of society, regarding health and empower them to be economically independent to foster practice of sustainable livelihood management.

The context:

The programme is intended to inculcate healthy livelihood among students and women by creating health awareness and giving them skill oriented education and knowledge to develop a culture of self empowerment. It also enables the students to develop their personality and responsibility towards self and family health and economy. The programme was also extended to local and nearby village's self-help-group women, for which free consultation was provided to them by Home Science department of our college.

The Practice:

Ours is an area of sugar cane cutting workers. The students of college find it difficult to engage in part time vocation as a course and time table does not allow them the required flexibility and freedom. Most of the students especially girls find it difficult to meet both ends as they have to look after their families in absence of their parents. So the college has tried to provide this knowledge to students as a part of the syllabus of Home science, as it provides education as well as practical knowledge to girls and society women. The college provides infrastructure and necessary facilities to students and local women.

Evidence of success:

The programme had enabled the student's interest in health awareness and learning vocation oriented skills to meet their minimum daily needs. Students had organized exhibition of prepared handicraft materials at college level.

Problem encountered and recourses required:

It requires both human and financial support for the programme to run appropriately and gain market for handicraft materials. Along with financial support, dropout rate of girls due to social and family problems is a major problem.

Note:

Health awareness programme had achieved praise by various educational institutions of taluka and society. Need of women empowerment had created a new version of independence among female students of college and especially women of self- help-group. For which college sees it as a great opportunity to serve the local community to fulfil the goal of **"Social Development"**.
